No. BRPD(BMMA)651/9(62)DA/2024-7448 dated August 27, 2024 dissolved the Board of Directors of Global Islami Bank PLC and subsequently reconstituted the Board of Directors through the appointment of 5 (five) Independent Directors to the Board of the Bank vide its Letter No. BRPD(BMMA)651/9(62)DA/2024-7449 dated August 27, 2024.

It is also to be mentioned that due to reconstitution of the Board by Bangladesh Bank, all Sponsors and Directors are unable to jointly hold minimum 30% (thirty percent) Shares of the paid-up capital of the Bank as per BSEC's Notification No. BSEC/CMRRCD/2009-193/217/Admin/90 dated 21 May 2019.
